The regular monthly meeting of the Planning Board of the Town of Cambria was called to order by John W. Phillips, Acting Chairman at 6:03 PM. Everyone was welcomed to the meeting, followed by the Pledge to the Flag.

A motion was made by Mr. Kroening and seconded by Mr. Schreader to approve the minutes of the January meeting as presented. Unanimously approved, motion carried.

**PSBD-2017-001 Robert Blackman
4472 Thrall Road, Lockport, NY 14094
Concerning -SBL# 107.00-1-3.4
Vacant land on Blackman Rd-1 Lot- 1,647'x 1,764'**

Mr. Blackman was present and the meeting and stated that he would like to create a 1,647' x 1,764' lot from the 66.4 acres that he owns on Blackman Road. The remaining property and the fruit stand are held in a family trust. The separate lot will remain in he and his wife's name. This will be done for estate planning purposes not development.

A motion was made by Mr. Kroening and seconded by Mr. Meal to waive the public hearing for this one lot minor sub-division, all in favor, motion carried.

A motion was made by Mr. Schreader and seconded by Mr. Meal to declare a negative declaration under SEQR, all in favor, motion carried.

A motion was made by Mr. Schreader and seconded by Mr. Kroening to grant this one lot minor sub-division to Mr. Blackman sub dividing a 1,647' x 1,764' lot from a 66.4 acre parcel, all in favor, motion carried.

4958 Blackman Rd, Lockport, NY 14094
Concerning- SBL# 92.00-1-80.11 Vacant Land on
Green Rd-1 Lot-150' x 475'

Mr. Critelli was present at the meeting and stated that he would like to create a 150' by 483.31' lot out of the 3.4 acre parcel that he owns on Green Road. The newly created lot would be located between the residence owned by Tricia Barone on the south side and his remaining vacant lot on the other side.

A motion was made by Mr. Kroening and seconded by Mr. Schreder to waive the public hearing for this one lot minor sub division, all in favor, motion carried.

Concerning-SBL# 92.00-1-35.41 Vacant Land on
Cambria Wilson Road-13.90 Acres
One lot minor Subdivision

Mr. Maloney was not present at tonight's meeting, but communicated with the board via phone. Mr. Maloney would like to move forward with the one lot minor sub-division. He plans to sell a 1.4 acre parcel to his neighbor. Mr. Maloney owns roughly 13.90 acres on Cambria-Wilson Road. He hopes to sell the remaining property to Joe Townsend who plans to farm the land. There are no drainage issues on this property. There is an issue with a 25' right of way on this property used by farmers to access this land. A right of way for a reserved paper road would also be required. Mr. Maloney asked if the board would approve a 25' right of way to access the property. The board felt a 25' right of way would not be acceptable. The board further stated that the 66' right of way should be located toward the center of the lots owned by Mr. Maloney. The Chairman would like Mr. Maloney to provide a detailed drawing of proposed layout. Mr. Maloney will need to communicate with Mr. McCann to let him know if he will have this plan ready to present at next month's meeting. A motion was made by Mr. Schreder and seconded by Mr. Kroening to table this one lot minor sub-division, all in favor, motion carried.
