Supervisor Ellis indicated that the Town took out a bond anticipation notice for the refuse carts about three years ago as part of the Modern contract. The Town made two payments on it and the third one was due in November. The Town decided that since it had money in the Refuse Reserve Fund and interest rates have increased, it would pay off the total amount of \$69, 600.00, thus saving over \$3,500.00 in a future interest payment.

The Supervisor is requesting an amendment to the 2023 Town of Cambria Refuse Budget, increasing the BAN Principal, SR9370.06, from \$23,200.00 to \$69,600.00 and BAN Interest, SR9370.07, from \$1,400.00 to \$3,186.00 for total Debt Services of \$72,786.00 and increase appropriated fund balance to \$555,886.00.

and Architects) for the Town of Cambria Drainage District of said Town and an estimated maximum cost of \$871,036.00 and authorizing the issuance of \$871,036.00 serial bonds of said Town to pay the cost thereof in accordance with the aforesaid order.

**NOW, THEREFORE, BE IT RESOLVED,** by the Town Board of the Town of Cambria, Niagara County, New York, as follows:

Section 1. The replacement of the existing culvert situate on Baer Road in the Town of Cambria, New York together with rebuilding the road over the culvert, acquisition of rights-of-way, temporary easements and all appurtenances thereto through a Bridge NY Culvert Replacement Project over the East Branch of 18 Mile Creek, Town of Cambria PIN 576505 as shown on the Map, Plan and Report prepared by Wendell (Engineers and Architects) for the Town of Cambria Drainage District of said Town at an estimated maximum cost of \$871,036.00 and authorizing the issuance of \$871,036.00 serial bonds of said Town to pay the cost thereof, in and for the Cambria Drainage District of the Town of Cambria, Niagara County, New York, as more fully described in the aforesaid proceedings, is hereby authorized.

Section 2. The maximum estimated cost of such specific object or purpose is \$871,036.00 and the plan for the financing thereof is \$871,036.00 by the issuance of the serial bonds of said Town hereby authorized to be issued pursuant to the provisions of the Local Finance Law. Further details pertaining to the said bonds will be prescribed in a further resolution or resolutions of this Town Board.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is thirty years, pursuant to subdivision 4 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will not exceed five years.

Section 4. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 5. The faith and credit of said Town of Cambria, Niagara County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such obligations as the same respectively become due and payable. There shall be annually apportioned and assessed upon the several lots and parcels of land within said Town of Cambria Drainage District which the Town shall determine and specify to be especially benefitted by the improvement, an amount sufficient to pay the principal and interest on said bonds as the same become due, but if not paid from such source, all the taxable real property in said Town shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal of and interest on said bonds as the same shall become due.

Section 6 The validity of such bonds and bond anticipation notes may be contested only if:

1.Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or

2. The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3. Such obligations are not authorized in violation of the provisions of the Constitution.

Section 7. Upon this resolution taking effect, the same shall be published in full in the Union Sun & Journal, the official newspaper, together with a notice of the Town Clerk, in substantially the form provided in Section 81.00 of the Local Finance Law.

## BRIDGE NY RESOLUTION BY TOWN OF CAMBRIA

(Culvert Project - Municipality Administered)

Authorizing the implementation and funding of 100% of the costs of a transportation project, of which qualified costs may be reimbursed from Bridge NY funds.

WHEREAS a project for the Bridge NY Culvert Replacement, Baer Road over E Branch of Twelve Mile Creek, P.I.N. 5765.05 (the "Project") is eligible for reimbursement of qualified costs from Bridge NY funding that calls for the post-reimbursement apportionment of the qualified costs to be borne at the ratio of 100% Bridge NY funds and 0 % non-Bridge NY funds; and

WHEREAS the Town of Cambria will design, let, and administer all phases of the Project.

WHEREAS the Town of Cambria desires to advance the Project by making a commitment of 100% of the costs of all phases of work for the Project or portions thereof.

NOW, THEREFORE, the Town of Cambria Town Board, duly convened does hereby,

RESOLVE, that the Town of Cambria Town Board hereby approves the Project; and it is hereby further

RESOLVED, that the Town of Cambria Town Board hereby authorizes the Town of Cambria to pay 100% of the cost of all phases of work for the Project or portions thereof, with the understanding that qualified costs will be reimbursed from Bridge NY funding; and it is further

RESOLVED, that the sum of \$871,036.00 is hereby appropriated from the Drainage District Fund and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that the Town of Cambria Town Board hereby agrees that the Town of Cambria shall be responsible for all costs of the Project, including costs which exceed the amount of reimbursement available from the NY Bridge Funding awarded to the Town of Cambria; and it is further

RESOLVED, that in the event the costs of the Project exceed the amount appropriated above, the Town of Cambria Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification thereof, and it is further

RESOLVED, that the Town of Cambria Town Board hereby agrees that the Town of Cambria hereby commits that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months; and it is further

RESOLVED, that the Town Supervisor of the Town of Cambria be and is hereby authorized to execute all necessary agreements, certifications or reimbursement requests with NYSDOT for State Aid and/or Bridge NY funding on behalf of the Town of Cambria in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's funding of the Project costs, and it is further

RESOLVED, that the Town of Cambria will be responsible for all maintenance of the Project; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and it is further

RESOLVED, this Resolution shall take effect immediately.

# LOCKPORT ROAD SEWER EXTENTION

Tim Walck, Wendel gave a brief background of the project and indicated that the Town has been awarded a \$500,000.00 grant from Empire State Development. This will be used to move forward with the Cambria Technology Park located on Comstock and Lockport Rds. A proposal has been submitted by Wendel for Lockport Rd. Sanitary Sewer for Design and Bidding.

### WATER SUPPLY VULNERABILITY ASSESSMENT - CYBERSECURITY

Tim Walck, Wendel, gave a background on the Water Supply Vulnerability Assessment-Cybersecurity project that they were authorized to work on in November. Mr. Walck reported that the work is 98% done and should be complete by the end of the year.

### FAIR VILLIAGE SEWER REPLACEMENT PROJECT

Tim Walck, Wendel, indicated that the Fair Village Sewer Replacement has been completed by NFP and Sons and the restoration will be done next spring.

Upon a motion duly made by Councilman Foe and seconded by Councilman Hurtgam, it was resolved to approve Change Order #1 Contract No. 2023-1 (due to not anticipated removal of rock and realignment of existing waterline) in the amount of \$38,511.08.
