The regular monthly meeting of the PLANNING BOARD of the TOWN of CAMBRIA was called to order at 8:00 P.M. by William Amacher, Chairman. He welcomed everyone to the November meeting followed by the Pledge to the Flag.

A motion was made by Mr. Hurtgam and seconded by Mr. Willett to approve minutes of meeting of October 15, 2007 as presented. Unanimously approved, motion carried.

07-16 MARTIN KROENING, 4165 Upper Mountain Road, Sanborn, N.Y. 14132, has submitted the following: Application for Subdivision Review, Request for Minor Subdivision Approval, Short Environmental Assessment Form, Agricultural Data Statement and copy of portion of town map highlighting subject parcel.

Mr. Kroening was present at this meeting and said he wishes to subdivide a lot from his farm located on the west side of Cambria Road, dimensions 125' frontage by 225' in depth, which is located next to lot of Dennis Scovazzo who has a double lot next to a proposed road.

A motion was made by Mr. Phillips and seconded by Mr. Willett to dispense with the public hearing on application of Mr. Kroening for a one lot minor subdivision located on the west side of Cambria Road. Unanimously approved, motion carried.

Building Inspector said there appears to be no problem with drainage on this lot.

Board members had no concerns on this application.

A motion was made by Mr. Phillips and seconded by Mr. Willett to declare **negative declaration under SEQR** on application of Mr. Kroening. Unanimously approved, motion carried.

A motion was made by Mr. Hurtgam and seconded by Mr. Mawhiney to **approve** application of Martin Kroening for a one-lot minor subdivision on the west side of Cambria Road, dimensions 125 feet by 225 feet. Unanimously approved, motion carried.

Tabled portion of Site Plan from October 2007:

2007-13 (10-10-07) Laura Horey, 2962 Saunders Settlement Road, Sanborn 14132. Mrs. Horey was present at this meeting.

Mr. and Mrs. David (Laura) Horey submitted application for Site Plan Approval to operate a tanning business, "Sun Beach Tanning", at the aforementioned address. At the October meeting Mrs. Horey requested a sign on the existing pole and a sign on the building, but did not know the exact

measurements of the proposed signs at that time. The Site Plan was approved in October excluding the signs and she was requested to come to tonight's meeting with the exact dimensions proposed. She said she would like a sign the same size as the one CVS has which would be placed next to the sign "Curves". She said it would be two (2) feet high on one side and three (3) feet high on the other side and would be sixteen (16) feet long. Mrs. Horey said she would like to open for business in February 2008. She showed pictures to the board.

There were no concerns of the board members on this issue.

A motion was made by Mr. Willett and seconded by Mr. Hurtgam to **approve** sign as shown to board members from her camera, namely two (2) feet high on one side and three (3) feet high on the other side by sixteen (16) feet in length. Unanimously approved, motion carried.

Mrs. Horey said the owner of the building is aware of the proposed tanning business at 2962 Saunders Settlement Road.

She was informed that she needs to get a building permit for the sign.
