NOTICE FOR A JOINT SEALED BID -  
REFUSE, WASTE COLLECTION AND DISPOSAL  
AND RECYCLABLES COLLECTION, PROCESSING AND MARKETING**

NOTICE IS HEREBY GIVEN that the Town Boards of Cambria, Newfane, Pendleton and Somerset, Niagara County, New York, (herein referred to as "the Municipalities") will receive a joint sealed bid for the collection and disposal of refuse, garbage and recyclables and marketing from within the applicable units of each respective municipality.

Sealed proposals will be received until 4:00 p.m. on the 7<sup>th</sup> day of September, 2016, at the Town of Cambria Town Clerk's Office, 4160 Upper Mountain Road, Sanborn, New York 14132, at which time the bids will be publicly opened and read.

The proposals are to be submitted for the furnishing, pursuant to a contract for an initial period of four years, based upon a one year bid price, of all labor, equipment and other facilities required for the collection, removal and disposal or marketing of refuse and recyclable materials from residential and eligible commercial properties in the Towns of Cambria, Newfane, Pendleton and Somerset.

Any contract with a participating municipality shall be for a period of four years, commencing January 1, 2017, with renewal for up to two additional three-year periods upon mutual agreement, with appropriate adjustments.

The specifications will be on file at the following locations: Cambria Town Clerk's Office, 4160 Upper Mountain Road, Sanborn, New York; Newfane Town Clerk's Office, 2737 Main Street, Newfane, New York; Pendleton Town Clerk's Office, 6570 Campbell Boulevard, Lockport, New York; and Somerset Town Clerk's Office, 8700 Haight Road, Barker, New York, and may be obtained there during its regular business hours.

The Municipalities, individually and/or jointly, reserve the right to reject or accept any and all bids for any reason. If an award is made, it will be to the lowest responsible bidder.

The Municipalities reserve the right to waive any informalities.

Each bid proposal must be submitted in a sealed envelope addressed to the Town of Cambria Town Clerk, with the bid bond

or other security, certification of compliance with the Iranian Divestment Act and the Non-Collusive Bidding Certificate enclosed. On the outside of the envelope it must be clearly noted "Bid for Refuse and Recyclables Collection" and must indicate the name, address and phone number of the bidder. Proposals not meeting the above format may be rejected.

The schedule for this solicitation of bids is included in the timeline presented below. The Municipalities reserve the right to modify this schedule as necessary, and is therefore tentative and subject to changes. All addendums and changes to this project will be sent via regular mail to all prospective respondents that have provided contact information.
