A motion was made by Mr. Sieczkowski and seconded by Mr. Schreader to approve the minutes of the July Meeting as presented, unanimously approved, motion carried.

**New Business      Thomas Ohol**  
**Minor                5832 Comstock Road, Lockport, NY 14094**  
**Sub-Division      Concerning Vacant Land on Meahl Road**  
**SBL# 121.00-1-45**

Mr. Ohol was present at the meeting and would like to create a 175' by 1,079' lot to be sold as a building lot. Mr. Ohol intends to keep roughly 72' as a driveway to access the back property. Mr. Billingsley stated that Mr. McCann had no issues with this minor sub-division, and there have been no drainage issues.

Discussion took place regarding dimensions of proposed lot, driveway and boundary lines of adjacent parcel 121.00-2-75.2 which is also owned by Mr. Ohol, and whether the lot to be subdivided was entirely in SBL# 121.00-1-45 or both of the above parcels.

Mr. Billingsley offered that the Board could approve this minor sub-division provided Mr. Ohol obtain a new accurate survey with dimensions of the proposed lot and the roughly 72' driveway he intends to keep.

A motion was made by Mr. Sieczkowski and seconded by Mr. Schreader to declare a negative declaration under SEQR, all in favor, motion carried.

A motion was made by Mr. Meal and seconded by Mr. Schreader to approve this Minor Sub-Division , subject to clarification with new survey providing dimensions of proposed lot and 72' driveway, all in favor, motion carried.
