Jon MacSwan, Supervisor, reported as follows:

Unicorn Drive Land Sale:

Negative SEQR

WHEREAS, the Town is currently the owner of an 8.9 acre vacant parcel of land in the Town of Cambria, County of Niagara, and State of New York, SBL # 120.17-2-1.5, situated on the west side of Unicorn Drive; and

WHEREAS, the Town is also currently the owner of a 4 acre vacant parcel of land in the Town of Cambria, County of Niagara, and State of New York, SBL # 120.17-2-1.12, situated on the south and east side of Unicorn Drive; and

WHEREAS, the Town is empowered to dispose of said properties, in accordance with the laws of the State of New York, for fair and reasonable consideration; and

WHEREAS, the sale of the properties is an Unlisted Action under the State Environmental Review Act ("SEQRA"); and

WHEREAS, the Town Board has received and reviewed the short Environmental Assessment Form ("EAF") from the Town Supervisor and has considered the potential environmental impacts of the sale of the properties pursuant to the requirements of SEQRA and found that the proposed action will not result in any significant adverse environmental impacts; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Cambria hereby adopts a Negative Declaration for the sale of the properties in the attached short EAF and determines that no Environmental Impact Statement is required; and be it further

RESOLVED, that the Town Supervisor of the Town of Cambria shall file a Negative Declaration along with this resolution with the Town Clerk.

Upon a motion duly made by Councilman Musall and seconded by Councilman Hurtgam, it was resolved to approve the resolution adopting a Negative Declaration for the sale of the properties located on the west side of Unicorn Drive SBL # 120.17-2-1.5 and south and east side of Unicorn Drive SBL # 120.17-2-1.12 in the attached short EAF and determines that no Environmental Impact Statement is required.

Unicorn Drive Land Sale: Sale of Property

WHEREAS, the Town is currently the owner of an 8.9 acre vacant parcel of land in the Town of Cambria, County of Niagara, and State of New York, SBL # 120.17-2-1.5, situated on the west side of Unicorn Drive; and

WHEREAS, the Town is also currently the owner of a 4 acre vacant parcel of land in the Town of Cambria, County of Niagara, and State of New York, SBL # 120.17-2-1.12, situated on the south and east side of Unicorn Drive; and

WHEREAS, the Town is empowered to dispose of said properties, in accordance with the laws of the State of New York, for fair and reasonable consideration; and

WHEREAS, the Town, by resolution dated May 9th, 2024, retained Hunt Commercial Real Estate to list the properties for sale to obtain the best sale price; and

WHEREAS, the Town has one written offer for the purchase of the properties in the amount of Four Hundred Fifty and 00/100 (\$450,000.00) Dollars; and

WHEREAS, as a condition to the conveyance of the Property, the purchaser shall be liable for any future environmental remediation costs or expenses associated with environmental contamination; and

WHEREAS, the Town desires to sell the properties.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Cambria does hereby declare that the properties list above are surplus and may, therefore, be sold in accordance with New York State Law; and be it further

RESOLVED, that the Town Board finds that \$450,000.00 to be fair and reasonable consideration for the properties; and be it further

RESOLVED, that the Town Board approves the sale of the properties to SJI Properties for a purchase price of \$450,000.00, upon the condition that the Purchaser assume all liability and expense for environmental remediation, if any and hold the Town of Cambria harmless from any future liability with the Property; and be it further

RESOLVED, that the Town Board hereby authorizes the Town Supervisor to execute any and all documents related to this sale; and be it further

RESOLVED, that the sale of the said Property is subject to a permissive referendum which will be published in the local newspaper after its adoption.

This resolution shall take effect thirty (30) days after its adoption.

Upon a motion duly made by Councilman Hurtgam and seconded by Councilwoman Brachmann, it was resolved to approve the sale of the properties located on the west side of Unicorn Drive SBL # 120.17-2-1.5 and south and east side of Unicorn Drive SBL # 120.17-2-1.12 to SJI Properties in the amount of \$450,000.00 upon the conditions listed in the above resolution and to authorize the Supervisor to execute all documents.
