**WHEREAS**, the Town of Cambria is contemplating the submission of an application for Community Development Block Grant (“CSBG”) funding from the New York State Office of Community Renewal (OCR) to provide financing to support the construction of a manufacturing facility on Junction Rd., Town of Cambria and

**WHEREAS**, the submission of such an application requires that a public hearing be held to obtain citizen comments regarding community and economic development needs in the Town and to comment on any specific project proposals, and

**WHEREAS**, at a special meeting of the Town Board of the Town of Cambria held at the Town Hall, 4160 Upper Mountain Rd., in said Town duly called by the Supervisor, for June 28, 2022 at 11:30 am

**IT WAS DULY RESOLVED** that a public hearing shall be held at the Town Hall, 4160 Upper Mountain Rd., Cambria, NY, on the 14<sup>th</sup> day of July, 2022 at 7:00 pm, for the purpose of considering the submission of an application for Community Development Block Grant funding from the New York State Office of Community Renewal to provide support to the construction of a manufacturing facility on Junction Rd., and to obtain citizens comments regarding community and economic development needs in the Town of Cambria and comments among specific proposals, and

**BE IT FURTHER RESOLVED** that at least eight (8) days’ notice of such hearing shall be giving by the Town Clerk by the due posting thereof at the Town Hall on the Town’s website together with publishing such notice at least once in the official newspaper of the Town.
