RIDGE ROAD (ROUTE 104) CULVERT ISSUES

Tim Walck, Wendel, gave an update to the Town Board regarding the work on Ridge Rd. Wendel is in receipt of a soil boring report. They finished design plans and submitted them to the DOT last week. He talked to two people at DOT who will review and approve the plan. Neither had comments and it is in the approval process. Mr. Walck feels it is safe for the Town to proceed with asking contractors for quotes.

Mr. Roberson, Attorney, indicated that the Town Board has been given an Order Calling Public Hearing for the Town of Cambria Drainage District. This is for authorization for the replacement in kind maintenance of existing culvert and collapsed storm-sewer being approximately 350 LF of emergency sewer line replacement of the collapsed storm-sewer; including 120 LF bore within NYS DOT Right of Way Route 104. This includes estimated maximum cost of \$275,000.00 and the environmental considerations in connection under SEQRA and authorizing if necessary the financing of same through the issuance of bonds.

The Public Hearing will be scheduled for Thursday, October 28, 2021, at 7:00 pm.

The following Resolution was offered by Councilman Roberts who moved its adoption, and seconded by Councilman Foe to wit:

WHEREAS, the Town Board of the Town of Cambria, Niagara County, New York, has had under consideration the installation and improvement of additional facilities for the Town of Cambria Drainage District of said Town; and

WHEREAS, said Town Board has duly caused a map, plan and report and estimate of cost for additional facilities to be prepared and submitted by Wendel, Architects and Engineers, duly licensed by the State of New York; and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State (collectively, the "SEQR Act"), the Town Board constitutes a "State Agency"; and

WHEREAS, the action under consideration by the Town Board (the "Action") consists of the replacement in kind maintenance of existing culvert and collapsed storm-sewer being approximately 350 LF of emergency sewer line replacement of the collapsed storm-sewer; includes 120 LF bore within NYS DOT ROW Route 104, as shown on the Map, Plan, and Report proposed by Wendel (Engineers and Architects) for the Town of Cambria Drainage District of said Town at an estimated maximum cost of \$275,000.00 and environmental considerations in connection therewith under SEQRA, (as shown on Map, Plan and Report prepared by Wendel, (Architect and Engineers) in and for the Town of Cambria Drainage District of said Town at an estimated maximum cost of \$275,000.00 and the financing of same through the issuance of bonds; and

WHEREAS, to aid the Town Board in determining whether the Action may have a significant effect upon the environment, the Town has prepared and submitted a Short Environmental Assessment Form (the "Questionnaire") with respect to the Facility, a copy of which is attached hereto as Exhibit A; and

WHEREAS, the Questionnaire has been reviewed by the Town Board; and

WHEREAS, it is now desired to call a Public Hearing on said Map, Plan and Report and estimate of cost pursuant to Section 202-b of the Town Law;

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Cambria, Niagara County, New York, as follows:

Section 1. A Special Meeting of the Town Board of the Town of Cambria, Niagara County, New York, shall be held at the Town Hall, 4160 Upper Mountain Rd, Cambria, New York, on the 28th day of October, 2021 at 7:00 p.m. for the purpose of conducting a Public Hearing on the Map, Plan and Report and estimate of cost referred to in the preambles hereof, at which time and place said Town Board will hear all persons interested in the subject thereof concerning the same.

Section 2. The Town Clerk is hereby authorized and directed to cause a Notice of Public Hearing to be published in the Union Sun & Journal and posted in the manner provided by law, which notice shall be in substantially the following form, to wit:

Town of Cambria Town Board RESOLUTION DECLARING PUBLIC EMERGENCY

BE IT RESOLVED that pursuant to Section 4 of General Municipal Law Section 103, the Town Board of the Town of Cambria hereby declares that the need to immediately repair, replace and reconstruct the culvert situate under NYS Rte. 104 (Ridge Road) in the Town of Cambria, Niagara County, New York in the vicinity of the Hurtgam-Faery premises to be a public emergency arising out of the 500-1000 year rainstorm occurring on Tuesday, July 20, 2021 that washed out, due volume of water and the force of the same, the culvert running underneath NYS Rte. 104. The wash-out of the culvert resulted in the inability to drain storm water from the premises south of Rte. 104, causing extensive flooding and property damage, as the condition of blocked drainage due to the culvert washout of the affected premises, and with winter weather quickly approaching, as immediate remedial action is necessary and cannot wait competitive bidding or competitive offerings, necessary contracts for the public work and purchases of supplies and materials for the needed repairs are hereby authorized by the Town Board of the Town of Cambria and,

It is **FURTHER RESOLVED** that the Town Engineer is authorized to put a "hold" on materials and supplies necessary for repairs.

Upon a motion duly made by Councilman Roberts and seconded by Councilman Musall it was resolved to approve the resolution to declare Public Emergency arising out of the 500-1000 year rainstorm occurring on July 20, 2021 that washed out, due volume of water and the force of the same, the culvert running underneath NYS Rte. 104. The wash-out of the culvert resulted in the inability to drain storm water from the premises south at Rte. 104.

BEAR RIDGE SOLAR PROJECT

Supervisor Ellis indicated that the litigation that the Town entered into along with other towns and entities has been dismissed by the judge in Albany. This was expected since that takes place in the Albany courts. The decision will be appealed. He has also received a message from Cypress Creek that they have been reaching out to the local Fire Companies in order to set up a Zoom type meeting in order to talk about fire safety and procedures regarding installation. An in person meeting is being requested by those involved and they are awaiting a response. Cypress Creek is trying to get their application submitted and had to delay it another week.

CONCERNS OF CITIZENS

- Sharon Tazner, Subbera Rd. asked if an informational letter will be sent out regarding the proposed solar project. Supervisor Ellis indicated there will be. Ms. Tazner mentioned the 2nd Annual Halloween Trunk or Treat Event to be held on Saturday, October 30 at the Town Park from 2 pm to 5 pm. She thinks it is a great thing for the community.
- A Town Resident commented on how nice the new Town Park sign looks and asked if the Park be open in the winter. Supervisor Ellis said yes, and there will be more activity with the ice rink and the walking path will be cleared of snow. The snow at the park takes second place to clearing the roads and fire stations. However, the comfort station will not be open because there is no heat.

MODERN DISPOSAL / TRASH/RECYCLING AND BULK PICK UP

Supervisor Ellis reported that the Town is having significant problems with Modern on the trash/recycling/bulk pick up. The Town went with trash carts at the insistence of Modern and Waste Management in order to save on labor by going to one person in the truck. The Town has been having trouble for some time with getting notifications late Wednesday afternoon that the bulk pickup will be delayed until Saturday. It goes up on the Town's website but not everyone reads the website. A call was placed to Dawn Timm, the County Coordinator, and there will be a meeting with representatives from four towns and the County Coordinator and the people from Modern. This will be October 28, in the Community Room. Modern is not following through on their end of the contract.

NEW BUSINESS

PLANNING BOARD AND ZONING BOARD OF APPEALS VACANCIES

Supervisor Ellis indicated that there are a couple vacancies on the Planning Board and the Zoning Board of Appeals.

MARIJUANA RETAIL SALES

Supervisor Ellis indicated that NYS passed a law authorizing marijuana use within the state. They tend to pass laws and try to draw up regulations to implement the law. The State provided a procedure whereby if a municipality doesn't do anything, then they can have retail sales and dispensaries within the municipality. If you opt out of that provision, you must do this by December 31, 2021 and you will not allow retail dispensaries and or on site consumption licenses within the town. Later, when the regulations come out, the town can decide whether or not it will opt back in, and where it will be allowed within the town. There are many things to consider with this. For instance the moral and law enforcement aspects. Until the regulations are developed, the Town does not know what it will be dealing with. At this time, the wiser course of action is to opt out and wait until the regulations come through and decide if it fits in with the zoning and if changes need to be made to the ordinance to accommodate the regulations.

Upon a motion duly made by Councilman Hurtgam and seconded by Councilman Roberts, it was resolved to schedule a public hearing for November 4, 2021, 7:05 pm, on Local Law No. 2-2021 opting out of allowing cannabis retail dispensaries and on site consumption as otherwise authorized under Article 4 of the Cannabis Law of the State of NY.
