PLEASE TAKE NOTICE that the Town Board of the Town of Cambria will conduct public hearings on the matters referred to herein at the Town Hall, 4160 Upper Mountain Road, Town of Cambria, NY on the 5<sup>th</sup> day of November 2020 at 7:00 PM. Said public hearings shall be as follows:
